

## Redwood Discovery Museum Rules and Liability Waiver: Kids Night

Our goal is to provide an environment for successful learning, development, and play for all attendees of Kids Night. Clarifying all expectations for appropriate behavior helps us accomplish that environment. Parents/guardians are expected to go over the Kids Night rules and expectations before entering the space. Though the Redwood Discovery Museum is always dedicated to finding solutions to ensure that all children who want to attend Kids Night are able to; for their safety and the safety of others, all attendees will be asked to adhere to the following rules at all times:

- All attendees must follow direction and listen to museum staff
- All Attendees are expected to help clean up after themselves
- No running (walking feet at all times)
- Gentle hands; no throwing, hitting, climbing, or incorrectly using toys or exhibits
- Use kind words at all times
- Share the space; take turns with toys and exhibits
- Please have general awareness and respect for everyone's bodies

The Redwood Discovery Museum is a space for everyone to share, and respect for its rules, guests, exhibits, and employees will be an expectation during our Kids Night program. An excessive disregard of our rules will result in parents/guardians being notified and the child being sent home early. If the behavior continues and the child's parents/guardians have been notified more than once, the child will be asked to take a break, or be permanently removed from attending Kids Night depending on the discretion of the museum staff and management.

By signing below you are agreeing, in perpetuity, to the rules and safety guidelines of the museum.

### Hold Harmless Agreement

I am aware that during the activity in which I am participating through the Redwood Discovery Museum (RDM), I will be exposed to certain risks and hazards which may result in property damage, personal injury, or death. In consideration of being permitted to enroll in and/or participate in the outing trip, class, instruction, parent directed play time, or other activity, I agree to indemnify, save and hold harmless the Redwood Discovery Museum, their directors, employees and associate agencies from any loss, liability, damage, or cost that may incur due to my child's (ward's) activities in the museum. I hereby release, waive, discharge, and covenant not to sue RDM, their Directors, Officers, employees, associated coalition agencies, and agents (hereinafter, referred to as "Releasees") from all liability to me, my personal representatives, assigns, heirs, and next of kin for any loss or damage in any claim or demands therefore, on account of property damage, personal injury, or death, whether caused by negligence of the Releasees or otherwise, arising out of the outing, trip, class, instruction, parent directed play, or other activity. I further expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and as inclusive as permitted by the laws of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect. I have read and voluntarily signed the Release, Waiver, and Indemnity Agreement and further agree that no oral representation, statement, or inducements not contained in this document have been made. On my behalf, and on the behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the RDM and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. The undersigned have READ, UNDERSTAND, AND ACCEPT this agreement, and by signing this agreement, all parties agree to all the aforementioned terms, conditions, and policies.
